The conference is a direct result of a partnership amongst these two institutions who are committed to support research, evaluation, and quality improvement projects to improve health outcomes and the continuous formation of health professionals in the North.

The 2023 edition, whose title was "Looking to the Future, health in the North" was mainly an inperson event that brought participants from all northern regions as well as presenters and visitors from other parts of the province.


1. Which of the following term/role best describes your primary affiliation?





2. I learned about a research and quality improvement that could inform my work:






3. I have obtained new skills or knowledge to build or enhance research, quality improvement, or policy opportunities:









 - More availability in number and in seating capacity, some of the workshops were full in registration time but had seating spaces in the end.



- 9. What can be done to improve Concurrent Sessions in the future?
 - More time
 - Bigger space
 - Slightly longer time some presentations were cut short.
 - Maybe a bit more time for questions and discussion.
 - As a first-time presenter at this conference, I wasn't sure how to bring my presentation to use with the technology. I brought both a USB with the presentation on it and my own computer to plug-in if needed. The facilitator of the room indicated there was no preference and I could use either and so I chose to use my own computer and plug it in by an HDMI cord for presentation. However, a minute or two into the presentation I realized that the online participants couldn't see the presentation, but it was too late to backtrack to fix this. Knowing this ahead of time would've allowed me to select the option of loading my presentation via the USB with the existing room technology so that all attendees, both in person and virtual, could benefit from the presentation.
 - Give more time to presenters. The concurrent session I attended was rushed.
 Speakers were given only 20 minutes to speak. They skipped information that would be valuable to me. Considering I came all the way from Fort St. John, I want to learn everything possible. I felt guilty asking all my questions as I felt I was taking up time.
 - The variety was great. Not sure if sign up is needed...attended one that people walked away from because of no seating and another with very few attendees.
 - The time was too short and too much content was put into small brackets of time. Perhaps fewer presenters with a sliver of additional time for each would make it so info could be absorbed.









- Maybe a bit longer, 3 x 30 minutes instead of 3 x 20. Had a few sessions go over and/or run into technical issues that ate into time.

 - Informal time to discuss interest with the keynote speaker.







